

# Rules on the protection of personal data

## **Personal data Administrator + Processor is:**

Eurocamping Bojkovice, s.r.o., Štefánikova 1008, 687 71 Bojkovice.

Personal data may also be processed by any employee of Eurocamping Bojkovice s.r.o.

### **1. Information**

within the meaning of Section 5 paragraph 2 of Act No. 101/2000 Coll. on the Protection of Personal Data, as amended (hereinafter referred to as the Personal Data Protection Act) and in accordance with Article 6 (1) (a) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95 / 46 / EC (General Regulation on the Protection of Personal Data = GDPR), effective from 25 May 2018,

**we inform to collect, store and process your personal data provided to Eurocamping Bojkovice, s.r.o.**

### **2. What data will be processed ?**

name, surname or business name, address (street, city number, postal code, state, nationality) ID card or passport number, email address, telephone number, number of people, age of children, the beginning and end of the accommodation, IP address.

### **3. Personal data will be processing and storing**

Personal data which stated in point 2.

**Eurocamping Bojkovice, s.r.o. will collect, store, and process for the following purposes:**

to conclude a contract,

to send notifications and announcements relating to a business case,

to a statutory duty under Act No. 565 on Local Fees and according to Act No. 326 on the Residence of foreigners.

### **4. Retention period.**

At the latest, Eurocamping Bojkovice s.r.o. will store personal data for 6 years.

### **5. How will personal data be processed and stored?**

machine-driven (computer-aided) by computer programs, in writing, in handwritten and paper form.

Personal data are not freely accessible to other entities, except for statutory obligations.

## **6. Data subject's rights, information and access to personal data**

As a data subject, I have the right to access my data, I have the right to correct or delete it, or to restrict the processing. I have the right to request information about which personal data is processed and I have the right to request explanations regarding the processing of personal data.

Furthermore, I have the right to object to the processing, as well as the right to data portability (that is, the right to obtain personal data concerning me which I have provided to the controller in a structured, commonly used and machine-readable format, as well as Article 20 GDPR)

As a data subject, I have the right to contact the Administrator or the Personal Data Protection Authority if there is any doubt about compliance with personal data processing obligations.

Eurocamping Bojkovice, s.r.o., declares that the automated decision making, including profiling, referred to in Article 22 (1) and (4) of the GDPR is not processed. Eurocamping Bojkovice, s.r.o., declares that personal data is not processed for scientific or historical research purposes or for statistical purposes.

Eurocamping Bojkovice, s.r.o, claims to process personal data: machine-driven (computer-aided) by computer programs, in writing, in handwritten form.

## **7. Final Provisions**

As a data subject I declare that I am aware of my rights under the provisions of paragraphs 12 and 21 of the Personal Data Protection and Rights Act under the GDPR.

I declare that all provided data is accurate and true and is provided on a voluntary basis.

Eurocamping Bojkovice, s.r.o., declares that it will collect personal data to the extent necessary to fulfill the purpose and process it only in accordance with the purpose for which it was collected.

This consent is a free and conscious manifestation of the will of the data subject, the content of which is the consent of the subject with the processing of personal data.
